ASQ's and Initial Interventions - Dick Parrish	<ul style="list-style-type: none"> • 347 ASQ's were completed for the month of December for fiscal year 2016 - 2017. • Sixty-six children required ILP's and 9 were referred to the Inclusion Coordinator during the same time period.

Inclusion Services – Lana Johnson	<ul style="list-style-type: none"> • In December 2016, Lana Johnson had 11 referrals from ASQs and 5 from outside agencies. These resulted in 6 referrals to Early Steps and 5 referrals to FDLRS. • In January 2017, there were 13 referrals from ASQs and 5 from outside agencies. Subsequently, there were 8 referrals to Early Steps and 5 referrals to FDLRS in January. 	
Vision and Hearing Screenings – Jill Corbett	<ul style="list-style-type: none"> • In January 2017, the ELC screener provided hearing and vision screenings for 395 children in 11 facilities, and the Lion's Club completed 49 screenings for children in 3 child care facilities. • Of the 395 children screened, 55 hearing referrals and 39 vision referral were made. • To date for FY 2016-2017, there have been a total of 227 hearing referrals and 159 referrals for vision. 	
Nursing Update - Patricia Hansen	<ul style="list-style-type: none"> • Twenty-three health and safety trainings are being offered for child care providers in Lee, Collier, and Hendry/Glades Counties. Registration is available on the ELC website. • The Blue Zones Project of SW Florida is expanding from Naples into Bonita Springs and Estero. • Florida is currently in peak influenza season.
