- 1) Create a profile on Save the Children's learning management system by visiting: [Save the Children - CollaborNation®](#) or scan the QR code above. Select, "Create Account" and follow the prompts.

Frequently Asked Questions:

Who should participate?

This training is available to Directors and Owners of child care centers and programs within the Gulf Coast Region and the Midwest Region. The maximum number of participants is set at 200 participants.

Does my center or program need to be licensed to participate?

No, Save the Children trainings are accessible to all child care facilities. If you are an Owner or Director of a child care center or program, we encourage you to participate.

What is the cost for the training?

There is no cost associated with this virtual training.

May I receive clock hours for this training?

Save the Children staff are working with local Child Care Resource & Referral Agencies to ensure this training is eligible for clock hours. At the completion of the training, each participant will receive a 'Certificate of Completion' containing the following information: the participants' name, training date, title of the training, trainer's name, length of training.

Will there be other training dates available?

Save the Children staff will make additional training available based on determined need.
