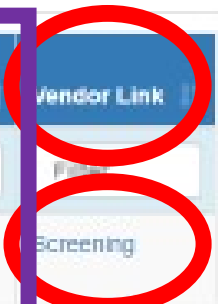
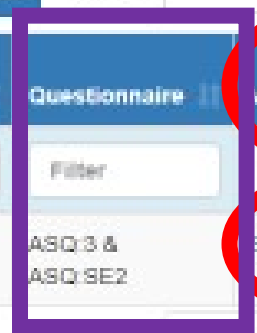

# Individual Learning Plans

ALL Child Screenings (ASQ's) for School Readiness children need to go through the Provider Portal. This includes rescreening after ILP's.

- Provider will receive an email with the information on activities to complete with the child or children.
- Activities are to be done for 8 weeks.
- The child re-screen will be put in the portal about one week before the screening is due.

# VPK Final Assessment Period, AP3

**VPK AP3 is due no later than 15 calendar days from the end of your VPK Program.** You can and will receive a Non-Compliance after the 15 days if your assessments have not been entered. You can do them earlier, up to 45 calendar days for Bright Beginnings if you like.

- If you are part of the STAR Early Literacy Pilot Program you must do ***both*** the regular AP3 ***and*** the computerized AP3.
- If you had to change your end date due to COVID closures, please contact me in writing so I can update Bright Beginnings!

I have not been arrested with disposition pending or found guilty of, regardless of adjudication, or entered a plea of nolo contendere or guilty to, or have been adjudicated delinquent and the record has not been sealed or expunged for, any offense prohibited under any of the following provisions of the Florida Statutes or under any similar statute of another jurisdiction for any of the offenses listed below:

Section 784.011	assault, if the victim of offense was a minor
Section 784.03	battery, if the victim of offense was a minor
Section 787.01	kidnapping
Section 787.02	false imprisonment
Section 787.025	luring or enticing a child
Section 787.04(2)	taking, enticing, or removing a child beyond the state limits with criminal intent pending custody proceeding
Section 787.04(3)	carrying a child beyond the state lines with criminal intent to avoid producing a child at a custody hearing or delivering the child to the designated person
Section 790.115(1)	exhibiting firearms or weapons within 1,000 feet of a school
Section 790.115(2) (b)	possessing an electric weapon or device, destructive device, or other weapon on school property
Section 794.031	carrying a firearm on school property

I understand that I must acknowledge the existence of any applicable criminal record relating to the above lists of offenses including those under any similar statute of another jurisdiction, regardless of whether or not those records have been sealed or expunged. Further, I understand that, while employed or volunteering at Name of center in any position that requires background screening as a condition of employment, I must immediately notify my supervisor/employer of any arrest and any changes in my criminal record involving any of the above listed provisions of Florida Statutes or similar statutes of another jurisdiction whether a misdemeanor or felony. This notice must be made within one business day of such arrest or charge. Failure to do so could be grounds for termination.

I attest that I have read the above carefully and state that my attestation here is true and correct that **my record does not contain any of the above listed offenses**. I understand, under penalty of perjury, all employees in such positions of trust or responsibility shall attest to meeting the requirements for qualifying for employment and agreeing to inform the employer immediately if arrested for any of the disqualifying offenses. I also understand that it is my responsibility to obtain clarification on anything contained in this affidavit which I do not understand prior to signing. I am aware that any omissions, falsifications, misstatements or misrepresentations may disqualify me from employment consideration and, if I am hired, may be grounds for termination or denial of an exemption at a later date.

# New VPK Bill

- Moves OEL under DOE as a Division
- Emergent Literacy for Lead Teachers
  - 3 courses by 7/1/2022, then every 5 years (available online)
- Class 1 Violations
- Possible Curriculum Updates
- VPK Program Assessment Minimum Threshold
  - Changes to VPK Program Assessment
  - Changes to Child Assessment/Learning Gains
- Be on the lookout for OEL rule workshops and ELC VPK provider meetings
